QuickBooks Desktop Direct Connect Instructions

WINDOWS SETUP

For current QuickBooks users with Web Connect (File Imports from online banking)

- 1. Backup QuickBooks Windows Data File & Update.
 - Choose File > Back Up Company > Create Local Backup
 - Download the latest QuickBooks Update. Go to Help > Update QuickBooks Desktop.
- 2 Complete a final transaction import and match downloaded transactions.
 - Complete one last transaction update before the change to get all of your transaction history up to date.
 - Accept all new transactions into the appropriate registers. (required)

For new Direct Connect or new Dime Direct Connect Customers:

- 1. Backup QuickBooks Windows Data File using the instructions above.
- 2. Deactivate any current online banking connection for accounts connected to financial institution that is requesting this change.
 - Choose Lists menu > Chart of Accounts.
 - Right-click on the first account you would like to deactivate and choose Edit Account.
 - Click the Bank Feeds Settings tab in the Edit Account window.
 - Select Deactivate All Online Services and click Save & Close.
 - Click **OK** for any alerts of messages that may appear with the deactivation.
 - Repeat steps for any additional accounts that apply.
- 3. Reconnect Online Banking connection for accounts that apply.
 - Choose Lists menu > Chart of Accounts.
 - Right-click on an account you would like to activate and choose Edit Account.
 - Select Set Up Bank Feeds on the bottom of the popup screen and select Yes in the dialog box that will appear.

- Enter your institution's name in the search field and select **Continue**.
- Double click on Dime Community Bank Bus Direct.

• Once approved, return to the bank feed setup. Select Dime Community Bank-Bus and re-enter the credentials from Step 2.

• The system will present the accounts to be linked. Ensure you associate the accounts to the appropriate accounts already listed in QuickBooks. Link to your existing accounts in the drop-down options labeled **Select Existing** or **Create New**.



Important: Do NOT select "Create New Account" unless you intend to add a new account to QuickBooks. If you are presented with accounts you do not want to track in this data file, choose Do Not Add to QuickBooks.

• After all accounts have been matched, click **Connect** and then click **Close**.
