To calculate your earnings allowance, we apply the earnings credit rate to the available collected balance in your account. The earnings credit rate is a variable rate that the Bank can change at any time. The rate appears on your client analysis statement. If your earnings allowance is greater than the total eligible fees for a given statement period, we won't credit that amount to your account or carry it forward to the following statement period. In any statement period where your fees exceed your earnings allowance, we'll debit your account or invoice you for the difference.
